**Revised Recognition Order**

WHEREAS, permission was granted to the institution namely, **MAA REWATI COLLEGE OF EDUCATION, RUN BY MAA REWATI EDUCATIONAL AND WELFARE SOCIETY, PLOT/KHASRA NO.340/1KH/2, 350/1KH/2, VILLAGE - KHAIRI, POST OFFICE/ TEHSIL/TALUKA/TOWN/CITY/DISTRICT - MANDLA, PIN CODE - 481661, MADHYA PRADESH** under section 15(3)(a) of NCTE Act, 1993 for conducting D.El.Ed course of two years duration with an annual intake of 50 students vide order dated 20.06.2016.

AND WHEREAS, the institution preferred an appeal before the Council (NCTE) u/s 18 of NCTE Act, 1993, against the Recognition order dated 20.06.2016 and the Council vide order dated 16.10.2017 remanded the case to WRC.

AND WHEREAS, the aforesaid appeal order was placed in the 283<sup>rd</sup> WRC meeting held on November 14-15, 2017 and the Committee decided that "...This is a case of appeal. The Appellate Authority vide order dated 16.10.2017 remanded the case to WRC to consider the request of the institution for two units of D.El.Ed. course. The WRC re-examined the case and found that the institution satisfies the requirement of built-up area and land as specified in clause 6 of the Appendix-II of NCTE Regulations, 2014. Hence, **Recognition order be modified for two units of D.El.Ed. course.**"

NOW, THEREFORE, in exercise of the powers vested under Section 15(3)(a) of the NCTE Act, 1993 and in accordance with the Regulations, 2014, the Western Regional Committee, NCTE hereby grants recognition to **MAA REWATI COLLEGE OF EDUCATION, RUN BY MAA REWATI EDUCATIONAL AND WELFARE SOCIETY, PLOT/KHASRA NO.340/1KH/2, 350/1KH/2, VILLAGE - KHAIRI, POST OFFICE/ TEHSIL/TALUKA/ TOWN/CITY/DISTRICT - MANDLA, PIN CODE - 481661, MADHYA PRADESH** for conducting **D.El.Ed.** programme of 2 (Two) years duration with an annual intake of **100 students (two basic units)** from the academic session **2018-2019**.

The institution shall gradually move towards becoming a composite institution as per clause 8(1) of the NCTE Regulations, 2014.

The institution shall comply with various other norms and standards prescribed in the NCTE Regulations, as amended from time to time.

The institution shall make admissions only after it obtains affiliation from the examining body in term of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.

The institution shall ensure that the required number of academic staff for conducting the course is always in position.

The recognition is subject to fulfilment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, State Government etc. as applicable.

The institution shall submit to the Regional Committee a Self- Appraisal Report at the end of each academic year along with annual statement of accounts duly audited by a Chartered Accountant.

**The institution shall fill the GIS information on the NCTE website within one month from the date of this order.**

The institution shall maintain & update its web-site as per provisions of NCTE Regulations and always display the following as mandatory disclosure:-

- Sanctioned programmes along with annual intake in the institution;
- Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.

- c) Name of faculty members who left or joined during the last, quarter;
- d) Names of Students admitted during the current session along with qualification, percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e) Fee charged from students;
- f) Available Infrastructural facilities;
- g) Facilities added during the last quarter;
- h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i) The affidavit with enclosure submitted along with application.
- j) The institution shall be free to post additional relevant information, if it so desires.
- k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

If the institution contravenes the provisions of the NCTE Act, Rules, Regulations and Orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section 17(1) of the NCTE Act, 1993.

**The decision for grant of recognition to the institutions for D.El.Ed. course has been taken by the WRC in the light of the order dated 13.05.2016 of the Hon'ble Supreme Court in SLA No.5102/2016 and is subject to the final outcome in the said SLA.**

**Recognition order dated 20.06.2016 be treated as cancelled from the date of issue of this revised recognition order.**
