

### 3. सीटों का आरक्षण :

#### 3.1 आरक्षण प्रतिशत :

अ. मध्यप्रदेश के मूल निवासियों के लिए आरक्षित 75 प्रतिशत एवं बाहरी राज्यों हेतु उपलब्ध 25 प्रतिशत स्थानों में से विभिन्न श्रेणियों के लिए स्थानों का आरक्षण प्रतिशत निम्नानुसार होगा :

1	अनुसूचित जाति	16 प्रतिशत	15 प्रतिशत
2	अनुसूचित जनजाति	20 प्रतिशत	7.5 प्रतिशत
3	अन्य पिछड़ा वर्ग (कीमी लेयर छोड़कर)	14 प्रतिशत	14 प्रतिशत
4	आर्थिक रूप से कमजोर वर्ग (ई.डब्ल्यू.एस.)	10 प्रतिशत	10 प्रतिशत

नोट: मध्यप्रदेश के राजपत्र क्रमांक 349 भोपाल दिनांक 14.08.2019 में प्रकाशित संशोधन क्रमांक 13681-227-इक्कीस-अ (प्रा.) अधि. दिनांक 13.08.2019 के द्वारा अन्य पिछड़ा वर्ग के आरक्षण में संशोधन किया गया। रिट याचिका क्रमांक 5901/2019 द्वारा : सुश्री आशिता दुरे विरुद्ध मध्यप्रदेश शासन में माननीय उच्च न्यायालय, जयलपुर द्वारा दिनांक 19.03.2019 को पारित आदेश के परिपेक्ष्य में अन्य पिछड़ा वर्ग के लिए आरक्षण प्रतिशत की सीमा को 14 प्रतिशत ही रखा गया है। इस संबंध में माननीय न्यायालय के निर्णयानुसार इसे परिवर्तित किया जा सकेगा।

ब- मध्यप्रदेश राज्य के सामान्य, अनुसूचित जाति, अनुसूचित जनजाति एवं अन्य पिछड़ा वर्ग के प्रत्याशियों में विभिन्न संवर्गों का आरक्षण निम्नानुसार होगा :

1. सैनिक संवर्ग के प्रत्याशियों के लिये 03 प्रतिशत।
2. स्वतंत्रता संग्राम सेनानियों के पुत्र/पुत्रियों एवं पौत्र/पौत्रियों/नातियों/नातिनों के लिए 03 प्रतिशत।
3. निःशक्त प्रत्याशियों के लिये 05 प्रतिशत।
4. विधवा/परित्यक्ता के लिये 01 प्रतिशत।

3.2 महिलाओं के लिये आरक्षण शासन के नियमानुसार 30 प्रतिशत क्षैतिजीय (Horizontal) है। कुल स्थानों की 30 प्रतिशत सीटों पर महिलाओं को उनकी मेरिट (योग्यता क्रम) के आधार पर प्रवेश दिया जाएगा।

3.2.1 सैनिक संवर्ग (एस) : कुल स्थानों के तीन प्रतिशत सीटें क्षैतिजीय आरक्षण (Horizontal Reservation) के अधीन सैनिक कर्मचारियों व उनके पुत्र, पुत्रियों या पत्नियों के लिये आरक्षित होंगी। सैनिक वर्ग में रक्षा कर्मचारियों के रूप में सेवा कर चुके भूतपूर्व सैनिक, कार्यरत रक्षा कर्मचारी तथा ऐसे रक्षा कर्मचारी जिनकी सेवा के दौरान मृत्यु हो चुकी हो या जो सेवा के दौरान स्थाई रूप से विकलांग हो गये हों, आते हैं। इस वर्ग के अंतर्गत प्रवेश हेतु दावा करने वाले उम्मीदवार को इस आशय का प्रमाण पत्र प्रस्तुत करना होगा कि वह मध्यप्रदेश में व्यवस्थापित भूतपूर्व सैनिक का पुत्र/पुत्री है। भूतपूर्व सैनिक से तात्पर्य ऐसे व्यक्ति से है जो भारत सरकार के रक्षा मंत्रालय द्वारा जारी की गई, भूतपूर्व सैनिक की परिभाषा के अंतर्गत आता है। भूतपूर्व सैनिक के पुत्र/पुत्री के फलस्वरूप प्रवेश का दावा करने वाले उम्मीदवार को अपने पिता/माता का भूतपूर्व सैनिक संबंधी प्रमाण-पत्र तथा अपने पिता/माता के मध्यप्रदेश में व्यवस्थापित होने संबंधी प्रमाण पत्र संबंधित जिले के जिला सैनिक कल्याण अधिकारी (पूर्व पदनाम सचिव जिला सैनिक बोर्ड) से प्राप्त कर प्रस्तुत करने होंगे।

## Admission Guidelines 2019-20

### 12. Reservation: According to the reservation policy of the Madhya Pradesh government.

12.1] 16 and 20 percent seats will be reserved for Scheduled Caste (SC) and Scheduled Tribe (ST) applicants respectively. The categories of these two classes will be interchangeable.

12.2] 14 percent seats will be reserved for applicants belonging to backward classes (except creamy layer).

12.3] Sons/daughters and grandsons/granddaughters of freedom fighters, sons/daughters of soldiers who have attained martyrdom or become permanently disabled in the line of duty in the Indian Army and dependents of former and serving army personnel. 03 percent seats will be reserved for the children of the Central Armed Police Force and for the applicants of the disabled category of these categories jointly, by giving a surcharge of 10 percent marks to the applicants of the disabled category, the combined merit of three classes has been determined. Provided that this reservation will be made available only from the seats reserved for the concerned cadre. The priority order of personnel/officers of the Indian Armed Forces will be as follows

1. Widow of the martyr and their dependents during the war.
2. Permanently disabled, serving soldiers and their dependents during the war.
3. Dependents of martyrs in service during peace.
4. Permanently disabled persons and their dependents during service in peace.
5. Dependents of serving or ex-servicemen awarded with the following gallantry medals, Param Vir Chakra, Ashok Chakra, Best War Service Medal, Maha Vir Chakra, Kirti Chakra, Uttam Seva Medal, Vir Chakra, Shaurya Chakra, Yudh Seva Medal, Army, Navy / Air Mention in Sena Medal Letters.
6. Dependents of Ex-Servicemen.
7. Dependents of serving soldiers.

12.4] 3 percent seats will be reserved for the applicants of the disabled category, but this reservation will be made available only from the seats reserved for the concerned cadre. Disabled persons will be given a relaxation of 5% in the qualifying marks at the time of admission.

12.5] NCC For applicants who have passed 'C' certificate, 1 percent of the sanctioned seats in the college will be reserved at the postgraduate level.

12.6 Out of the available seats in all categories, 30 percent seats will be reserved for girl students.

12.7 Department of Higher Education, Government of Madhya Pradesh and its subordinate offices, Commissioner's Office, all concerned cadres for the wards of officers and employees working in higher education, principals, professors, librarians, sports officers, registrars and third and fourth class employees working in government colleges. Out of the available seats, 5% of the seats will be kept reserved.

12.8] If a reserved category candidate appears in the general category / open competition in the merit list as per rules due to getting more marks, then the reserved category seats will remain unaffected. But if such a student belongs to any other cadre like freedom fighters etc., then the seat of the concerned cadre will be considered as filled in that specific reserved category. Remaining seats of the concerned specific cadre will be filled as per eligibility

#### 12.9 Admission to Minority Status Colleges:

Minority institutions will have to register on the portal of the Department of Higher Education ([www.mphighereducation.nic.in](http://www.mphighereducation.nic.in)) and enter the information about the courses run by the respective university, their seat number, fee etc. in their institution on the portal, and verification of these courses. The concerned mapping will have to be done by the college by the stipulated date.

There will be no restriction of reservation of SC/SC/OBC in minority institutions. Minority institutions will have to enter the information of the students admitted with them in the online module available on the department's admission portal ([www.epravesha.nic.in](http://www.epravesha.nic.in)). This process must be completed by the last date fixed for reporting as per the online admission process schedule. Minority Institutions on the Higher Education.

12.9.1 Such non-government colleges which have the status of minority colleges, and want to apply for joining the offline admission process, then they will have to compulsorily submit the application along with the following documents to the Higher Education Department on the prescribed dates

- A. Updated no-objection certificate issued by the government for the current session.
- B. Updated affiliation certificate issued by the University for the current session.
- C. Valid certificate of being a minority institution/college.
- D. Certificate of updated Governing Body / Management list registered in Registrar Firm and Society office.
- E. Institution wise unitary information of minority category / non-minority category students admitted in the previous year.
- F. Application of the institution to keep it free from the online admission process.

12.9.2 Mapping colleges, while verifying the profile of the concerned minority college, will match the original copies of 6 documents mentioned in 12.9.1 and upload them on the portal along with the signature and Seal of the verification officer.

It is the responsibility of the concerned university to re-verify the colleges added on the portal and it is mandatory for them to verify through the link given on the portal within the given time limit. The responsibility of getting the above re-verification will also be of the concerned college. If the time limit is not re-verified by the university, then in this situation the said college will not be able to participate in the admission process.

12.10] If the percentage of reserved seats is less than half, then the reserved seats will not be available in the same category. Only if it falls between half to one percent, the number of reserved seats will be considered as one.

12.11] As per para 2.5 in the CLC round the reserved category vacancies mentioned earlier in the last phase will be available to the applicants of the unreserved (general) category.

12.12] Reservation rules issued by the government from time to time will be followed.

12.13] Such courses in the Ordinance for which admission is to be given through written examination. Eligible applicants will have to register their preference for the respective institution and course by registering on the portal. The concerned institution will conduct the entrance examination of the registered applicants and give admission as per rules. Will compulsorily enter the information of the admitted applicants on the portal.
